RE: Preliminary injunction on corrosion-resistant carbon steel flat products from Korea POR 08/01/09 through 07/31/10, for Pohang Iron & Steel Co., Ltd., & Pohang Coated Steel Co., Ltd. (A-580-816)

1. ON 06/05/2012, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION, AS CORRECTED ON 06/12/2012, ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM KOREA (A-580-816) FOR THE PERIOD AUGUST 1, 2009, THROUGH JULY 31, 2010.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 12-00090 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH 3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE MANUFACTURED AND/OR EXPORTED BY POHANG IRON & STEEL CO., LTD. ("POSCO") OR POHANG COATED STEEL CO., LTD. ("POCOS"), AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION, DURING THE PERIOD AUGUST 1, 2009, THROUGH JULY 31, 2010. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE ISSUED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THE INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 06/06/2012. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 06/05/2012.
