RE: Correction of message 5287303, dated 10/14/2015 concerning the antidumping duty order on certain frozen warmwater shrimp from the Socialist Republic of Vietnam (A-552-802)

1. This is a correction to message 5287303, dated 10/14/2015, to correct paragraph 3 of that message.
2. Paragraph 3 of message 5287303 contains an incorrect date referencing the effective date of the Court's Preliminary Injunction. Below is the fully corrected message.
3. On 10/13/2015, the U.S. Court of International Trade issued a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 4 which are subject to the antidumping duty order on certain frozen warmwater shrimp from the Socialist Republic of Vietnam (A-552-802) for the period 02/01/2013 through 01/31/2014. This PI was issued in connection with court number 15-00279.

Any such entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.

6. Effective immediately, CBP is instructed to follow the terms of the PI.

7. The PI applies to the liquidation instructions in message numbers 5275308, 5275307, 5275306, 5275305, 5275304, 5275303, dated 10/02/2015.
