RE: Notice of a preliminary determination in an antidumping duty investigation of circular welded carbon-quality steel pipe from India (A-533-852)

1. ON 06/01/2012, COMMERCE PUBLISHED IN THE FEDERAL REGISTER ITS AFFIRMATIVE PRELIMINARY DETERMINATION OF SALES AT LESS THAN FAIR VALUE IN THE ANTIDUMPING DUTY INVESTIGATION OF CIRCULAR WELDED CARBON-QUALITY STEEL PIPE FROM INDIA (77 FR 32562).
2. THE PRODUCTS COVERED BY THIS INVESTIGATION ARE DESCRIBED IN MESSAGE 1334303 DATED 11/30/2011. AS NOTED IN THAT MESSAGE, THE SCOPE ONLY COVERS MERCHANDISE THAT IS MANUFACTURED AND/OR EXPORTED BY ZENITH STEEL PIPES AND INDUSTRIES LTD. AND ANY SUCCESSORS-IN-INTEREST TO THAT COMPANY. AS NOTED IN PARAGRAPHS 4 AND 5 BELOW, ZENITH BIRLA (INDIA) LIMITED IS CONSIDERED TO BE A SUCCESSOR-IN-INTEREST TO ZENITH STEEL PIPES AND INDUSTRIES LTD. NOTE: THIS COMPANY MAY ALSO BE REFERRED TO AS ZENITH BIRLA LTD.
3. THIS INVESTIGATION HAS BEEN ASSIGNED INVESTIGATION NUMBER A-533-852.
4. FOR IMPORTS OF CIRCULAR WELDED CARBON-QUALITY STEEL PIPE FROM INDIA, CBP SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/01/2012. EFFECTIVE 06/01/2012, CBP SHALL REQUIRE, FOR SUCH ENTRIES, A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGIN FOR THE PRODUCER AND/OR EXPORTER LISTED IN THE COMPANY-DETAILS TABLE APPENDED TO THE BOTTOM OF THIS MESSAGE (I.E., ZENITH BIRLA (INDIA) LIMITED (PREVIOUSLY KNOWN AS ZENITH STEEL PIPES AND INDUSTRIES LTD.), WHICH HAS BEEN ASSIGNED COMPANY CASE NUMBER A-533-852-001).

THE DESIGNATION OF "M" IN THE APPENDED TABLE APPLIES WHERE THE MERCHANDISE WAS PRODUCED BY, EXPORTED BY, OR PRODUCED AND/OR EXPORTED BY THE NAMED COMPANY, ZENITH BIRLA (INDIA) LIMITED (PREVIOUSLY KNOWN AS ZENITH STEEL PIPES AND INDUSTRIES LTD.).

NOTE: THIS COMPANY MAY ALSO BE REFERRED TO AS ZENITH BIRLA LTD.

5. ANTIDUMPING DUTY ORDER A-533-502 COVERS PRODUCERS AND EXPORTERS OF CIRCULAR WELDED CARBON STEEL PIPES AND TUBES FROM INDIA OTHER THAN ZENITH STEEL PIPES AND INDUSTRIES LTD. (NOW KNOWN AS ZENITH BIRLA (INDIA) LIMITED). NOTE, THOUGH, THAT THE MERCHANDISE COVERED BY THE SCOPE OF A-533-502 (SEE, E.G., 51 FR 17384 (05/12/1986) IS NOT IDENTICAL TO THAT COVERED BY A-533-852 (SEE PARAGRAPH 2 ABOVE AND MESSAGE 1334303).

6. IN ACCORDANCE WITH T.D. 85-145, AT THE DISCRETION OF CBP, CBP OFFICERS MAY ACCEPT EITHER A SINGLE-ENTRY BASIC IMPORTATION AND ENTRY BOND OR A CONTINUOUS BASIC IMPORTATION AND ENTRY BOND ONLY IF THE AMOUNT OF THE ESTIMATED ANTIDUMPING DUTY IS LESS THAN FIVE PERCENT AD VALOREM (OR THE EQUIVALENT). OTHERWISE, WHERE THE IMPORTER HAS THE OPTION TO POST A BOND FOR ESTIMATED ANTIDUMPING DUTIES, CBP OFFICERS MUST REQUIRE A SINGLE-ENTRY BASIC IMPORTATION AND ENTRY BOND PURSUANT TO T.D. 85-145. YOU ARE INSTRUCTED TO ADHERE TO THE REQUIREMENTS OF T.D. 85-145 WITH RESPECT TO THESE BONDING REQUIREMENTS.
