RE: Correction of message 6187311, dated 07/05/2016 concerning the countervailing duty investigation on certain amorphous silica fabric from the People's Republic of China (C-570-039)

1. This is a correction to message 6187311, dated 07/05/2016, to revise paragraph 4 of that message, and to delete paragraph 5 of that message.
2. Paragraphs 4 and 5 of message 6187311 contain inappropriate references to the posting of bonds. All deposits are to be cash deposits only. The entire original message, other than the deleted portions dealing with the posting of bonds, remains unchanged and is contained below for your convenience.
3. On 07/05//2016, Commerce published in the Federal Register its preliminary affirmative determination and alignment of its final determination in the countervailing duty investigation of certain amorphous silica fabric from the People's Republic of China from 09/12/2016 until no later than 11/07/2016, thereby aligning it with the due date for the final determination in the antidumping duty investigation of certain amorphous silica fabric from the People's Republic of China (81 FR 43579).
4. The products covered by this investigation are described in message 6055303 dated 02/24/2016.
5. This investigation has been assigned investigation number C-570-039.
6. For imports of certain amorphous silica fabric from the People's Republic of China, CBP shall suspend liquidation of such shipments entered, or withdrawn from warehouse, for consumption on or after 07/05/2016. Effective 07/05/2016, CBP shall require, for such entries, a cash deposit equal to the subsidy rates for the following companies:
