RE: Notice of a final determination in an antidumping duty investigation of certain hot-rolled steel flat products from the Netherlands (A-421-813)

1. On 08/12/2016, Commerce published in the Federal Register (81 FR 53421) its final affirmative determination of sales at less-than-fair-value in the antidumping duty investigation of certain hot-rolled steel flat products from the Netherlands (A-421-813).
2. The products covered by this investigation are described in message 5257305, dated 09/14/2015.
3. This investigation has been assigned investigation number A-421-813.
4. For imports of certain hot-rolled steel flat products from the Netherlands, CBP shall continue to suspend liquidation of such shipments entered, or withdrawn from warehouse, for consumption on or after 03/22/2016. Effective 08/12/2016, CBP shall require, for such entries, a cash deposit equal to the margins for the producers and/or exporters listed below:

All Others

Case Number: A-421-813-000

Cash Deposit Rate: 3.73%

Producer and/or Exporter: Tata Steel IJmuiden B.V.

Case number: A-421-813-001

Cash deposit rate: 3.73%

5. If any entries of this merchandise are exported by a firm other than the producer, then the following instructions apply:

A. If the exporter of the subject merchandise does not have its own rate but the producer has its own rate, the cash deposit will be the producer's rate.

B. Where neither the exporter nor the producer currently has its own rate or the producer is

unknown, use the all-others rate of 3.73 percent to establish the cash deposit rate.
