RE: Notification of dissolution of open-ended injunction for diamond sawblades and parts thereof from the People's Republic of China entered on or after 03/22/2013 (A-570-900), Court No. 16-2314

This is an informational message, no action is required.

1. On 09/02/2016, the Court of Appeals for the Federal Circuit dismissed the case of Diamond Sawblades Manufacturers' Coalition v. United States (CAFC No. 16-2314, CIT No. 13-00168). As a result of this dismissal, the injunction to which message 5238306, dated 08/26/2015, refers enjoining liquidation of entries which are subject to the antidumping duty order on Diamond Sawblades from China that are subject to Certain Frozen Warmwater Shrimp from the People's Republic of China and Diamond Sawblades and Parts Thereof from the People's Republic of China (78 FR 18958, 03/28/2013) (notice of implementation of determinations under Section 129 of the Uruguay Round Agreements Act and partial revocation of the antidumping duty orders) produced and/or exported by the AT&M entity and/or any of its members, to the extent that such entries were or are made on or after 03/22/2013, dissolved on 09/02/2016. The members of the AT&M entity are: Advanced Technology & Materials Co., Ltd.; Beijing Gang Yan Diamond Products Co. (a/k/a Beijing Gang Yan Diamond Products Company); HXF Saw Co., Ltd. (a/k/a Yichang HXF Circular Saw Industrial Co., Ltd.); AT&M International Trading Co., Ltd. (a/k/a ATM International Trading Co., Ltd.); and Cliff International Ltd. (a/k/a Cliff (Tianjin) International Ltd., Cliff (Tianjin) International Ltd., Company).
2. Liquidation instructions for entries that are no longer subject to the injunction (message number 5238306, dated 08/26/2015) will be issued separately.
