RE: Preliminary injunction on certain frozen warmwater shrimp from the Socialist Republic of Vietnam for various companies for the period 2/1/2014 through 1/31/2015 (A-552-802), court no. 16-00205

1. On 10/31/2016, the U.S. Court of International Trade issued a preliminary injunction (PI) enjoining liquidation of entries identified in paragraph 2 which are subject to the antidumping duty order on certain frozen warmwater shrimp from the Socialist Republic of Vietnam (A-552-802) for the period 02/01/2014 through 01/31/2015. This PI was issued in connection with court number 16-00205.

2. This PI enjoins liquidation of entries which were exported by any of the following exporters:

4. Effective immediately, CBP is instructed to follow the terms of the PI.
5. The PI applies to the liquidation instructions in message number 6272303, dated 09/28/2016, message number 6272304, dated 09/28/2016, and message number 6278301, dated 10/04/2016.
