RE: Correction of message 6302301 dated 10/28/2016 concerning automatic liquidation instruction for Stainless Steel Sheet and Strip In Coils from the Republic of Korea POR 01/01/2015-12/31/2015, C-580-835

1. This is a correction to message 6302301, dated 10/28/2016 to correct the period of review of the reference line.
2. The reference line of message 6302301, dated 10/28/2016, contains the incorrect period of review for the automatic liquidation instruction for Stainless Steel Sheet and Strip In Coils from the Republic of Korea (C-580-835), the correct period of review is 01/01/2015 through 12/31/2015, which is now stated in the reference line.
3. Commerce does not automatically conduct administrative reviews of countervailing duty orders. Instead, reviews must be requested pursuant to section 751(a)(1) of the Tariff Act of 1930, as amended, and in accordance with 19 CFR 351.213.
4. Commerce has not received a request for an administrative review of the countervailing duty order for the period and on the merchandise identified below. Therefore, in accordance with 19 CFR 351.212(c), you are to assess countervailing duties on merchandise entered, or withdrawn from warehouse, for consumption at the cash deposit or bonding rate in effect on the date of entry. Liquidate all entries for all firms.

5. There are no injunctions applicable to the entries covered by this instruction.
6. Notice of the lifting of suspension of liquidation of entries of subject merchandise covered by paragraph 4 occurred with the publication of the notice of initiation of administrative review for the 08/2016 anniversary month (81 FR 71061, 10/14/2016). Unless instructed otherwise, for all other

shipments of stainless steel sheet and strip in coils from the Republic of Korea you shall continue to collect cash deposits of estimated countervailing duties for the merchandise at the current rates.

7. The assessment of countervailing duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated countervailing duties. The interest provisions are not applicable to cash or bonds posted as estimated countervailing duties before the date of publication of the countervailing duty order. Interest shall be calculated from the date payment of estimated countervailing duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.
