1. THIS IS A CORRECTION OF PARAGRAPH 2 IN MESSAGE 1108308 DATED 04/18/2011.

2. PARAGRAPH 2 OF MESSAGE 1108308 CONTAINED AN INCORRECT DATE WITH RESPECT TO THAI-I-MEI FROZEN FOODS CO., LTD.

3. PARAGRAPH 2 OF MESSAGE 1108308 READS AS FOLLOWS:

FOR ALL SHIPMENTS OF CERTAIN FROZEN WARMWATER SHRIMP FROM THAILAND PRODUCED AND/OR EXPORTED BY THE COMPANIES LISTED BELOW, EXCEPT THAI-I-MEI FROZEN FOODS CO., LTD., AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/2008 THROUGH 01/31/2009, ASSESS AN ANTIDUMPING DUTY LIABILITY OF 2.61 PERCENT OF THE ENTERED VALUE. FOR THAI-I-MEI FROZEN FOODS CO., LTD., ASSESS AN ANTIDUMPING DUTY LIABILITY OF 2.61 PERCENT OF THE ENTERED VALUE FOR ALL SHIPMENTS OF CERTAIN FROZEN WARMWATER SHRIMP FROM THAILAND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/2008 THROUGH 01/16/2009.

4. INSTEAD, PARAGRAPH 2 OF MESSAGE 1108308 SHOULD READ AS FOLLOWS:

FOR ALL SHIPMENTS OF CERTAIN FROZEN WARMWATER SHRIMP FROM THAILAND PRODUCED AND/OR EXPORTED BY THE COMPANIES LISTED BELOW, EXCEPT THAI-I-MEI FROZEN FOODS CO., LTD., AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/2008 THROUGH 01/31/2009, ASSESS AN ANTIDUMPING DUTY LIABILITY OF 2.61 PERCENT OF THE ENTERED VALUE. FOR THAI-I-MEI FROZEN FOODS CO., LTD., ASSESS AN ANTIDUMPING DUTY LIABILITY OF 2.61 PERCENT OF THE ENTERED VALUE FOR ALL SHIPMENTS OF CERTAIN FROZEN WARMWATER SHRIMP FROM THAILAND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 02/01/2008 THROUGH 01/15/2009, PURSUANT

TO REVOCATION (SEE MESSAGE NUMBER 9054202, DATED 02/23/2009).
