RE: Correction of message 6314304, dated 11/09/2016 concerning the ALIs on the AD duty order on certain passenger vehicle and light truck tires from the PRC (A-570-016)

1. This is a correction to message 6314304, dated 11/09/2016, to correct paragraph 3 of that message.
2. Paragraph 3 of message 6314304 should have included Shandong Xinghongyuan Tire Co., Ltd., which is subject to a new shipper review covering the period 08/01/2015 through 01/31/2016, in the list of companies for which entries should not be liquidated. In addition, the name of a company, Maxon Int'l Co., Limited, was misspelled in paragraph 3 and two companies (Nankang International Co., Ltd. and Nankang Rubber Tire Corp., Ltd.) that were omitted are now included. Below is the fully corrected message.
3. Commerce does not automatically conduct administrative reviews of antidumping duty orders. Instead, reviews must be requested pursuant to section 751(a)(1) of the Tariff Act of 1930, as amended, and in accordance with 19 CFR 351.213.
4. Commerce has not received a request for an administrative review or new shipper review of the antidumping duty order for the period and on the merchandise identified below except for the firms listed in paragraphs 5a and 5b. Therefore, in accordance with 19 CFR 351.212(c), you are to liquidate all entries for all firms except those listed in paragraphs 5a and 5b and assess antidumping duties on merchandise entered, or withdrawn from warehouse, for consumption at the cash deposit rate in effect on the date of entry, except where paragraphs 6 and/or 8 apply.

The injunction with court number 15-00255 in message number 5335316, dated 12/01/2015, is applicable to the entries produced and imported by ITG Voma Corporation; were subject to the U.S. International Trade Commission's final determination in the investigation of certain passenger vehicle and light truck tires from China, Inv. Nos. 701-TA-522 and 731-TA-1258, Certain Passenger Vehicle and Light Truck Tires from China, 80 Fed. Reg. 47,000 (Int'l Trade Comm'n Aug. 6, 2015) (final determination); and were entered, or withdrawn from warehouse, between 01/27/2015 and 07/25/2015, or between 08/06/2015 and 07/31/2016, the last day of the month prior to the anniversary month of the antidumping duty order (first antidumping administrative review period), and are subject to the antidumping duty order (A-570-016) published as Certain Passenger Vehicle and Light Truck Tires From the People's Republic of China: Amended Final Affirmative Antidumping Duty Determination and Antidumping Duty Order; and Amended Final Affirmative Countervailing Duty Determination and Countervailing Duty Order, 80 Fed. Reg. 47,902 (Dep't of Commerce Aug. 10, 2015) (Passenger Tires Orders) during the periods 01/27/2015-07/25/2015 and 08/06/2015-07/31/2016. Accordingly, until further notice continue to suspend liquidation of these entries until liquidation instructions are issued.

7. Notice of the lifting of suspension of liquidation of entries of subject merchandise covered by paragraph 4 occurred with the publication of the notice of initiation of administrative review for the 08/2016 anniversary month (81 FR 71061, 10/14/2016). Unless instructed otherwise, for all other shipments of certain passenger vehicle and light truck tires from the People's Republic of China

you shall continue to collect cash deposits of estimated antidumping duties for the merchandise at the current rates.

8. Entries for the period 07/26/2015 through 08/05/2015 should be liquidated without regard to antidumping duties. See message 5259303, dated 09/16/2015.

9. The assessment of antidumping duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated antidumping duties. The interest provisions are not applicable to cash or bonds posted as estimated antidumping duties before the date of publication of the antidumping duty order. Interest shall be calculated from the date payment of estimated antidumping duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.
