RE: Correction of message 6288305, dated 10/14/2016 concerning the countervailing duty order on drawn stainless steel sinks from the People s Republic of China (C-570-984).

1. This is a correction to message 6288305 dated 10/14/2016, to correct paragraph 1 of that message.
2. Paragraph 1 of message 6288305 contains incomplete information regarding the liquidation of entries. Liquidation instructions for Guangdong Yingao Kitchen Utensils Co., Ltd., Zhongshan Superte Kitchenware Co., Ltd., and Guangdong Dongyuan Kitchenware Industrial Co., Ltd. did not include a sentence to liquidate entries that entered under C-570-984-000 or other company-specific numbers for each of these companies. Below is the fully corrected message.
3. Commerce has rescinded the administrative review of the countervailing duty order on drawn stainless steel sinks from the People's Republic of China (C-570-984) covering the period 01/01/2015 through 12/31/2015 for the firms listed below. You are to assess countervailing duties on merchandise entered, or withdrawn from warehouse, for consumption during the period 01/01/2015 through 12/31/2015 at the cash deposit rate required at the time of entry.

Liquidate all entries for the following firms:

Company: Guangdong Yingao Kitchen Utensils Co., Ltd.

Case number: C-570-984-001. Entries may also have been made under C-570-984-000 or other company-specific numbers.

Company: Zhongshan Superte Kitchenware Co., Ltd.

Case number: C-570-984-003. Entries may also have been made under C-570-984-000 or other company-specific numbers.

Company: Guangdong Dongyuan Kitchenware Industrial Co., Ltd.

Case number: C-570-984-004. Entries may also have been made under C-570-984-000 or other company-specific numbers.

Company: Jiangmen New Star He-Tech Enterprise Ltd.

Case number: No case number was in place for this company during the period of review. Entries may have been made under C-570-984-000 or other company-specific numbers.

4. Notice of the lifting of suspension of liquidation of entries of subject merchandise covered by paragraph 3 occurred with publication of the notice of rescission of administrative review (81 FR 65626, 09/23/2016). Unless instructed otherwise, for all other shipments of drawn stainless steel sinks from the People's Republic of China you shall continue to collect cash deposits of estimated countervailing duties for the merchandise at the current rates.

5. There are no injunctions applicable to the entries covered by this instruction.

6. The assessment of countervailing duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated countervailing duties. The interest provisions are not applicable to cash or bonds posted as estimated countervailing duties before the date of publication of the countervailing duty order. Interest shall be calculated from the date payment of estimated countervailing duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.
