RE: Preliminary injunction on certain frozen fish fillets from Vietnam (A-552-801) for the period 08/01/2009 through 07/31/2010 for the companies listed in paragraph 3 below, court number 12-00087.

1. ON 04/13/2012, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN FROZEN FISH FILLETS FROM THE SOCIALIST REPUBLIC OF VIETNAM (A-552-801) FOR THE PERIOD 08/01/2009 THROUGH 07/31/2010.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 12-00087 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH 3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED TO THE UNITED STATES BY QVD FOOD COMPANY, LTD.; VINH HOAN CORPORATION; VAN DUC FOOD EXPORT JOINT COMPANY ("VAN DUC"); VAN DUC TIEN GIANG ("VD TG"); ANVIFISH CO., LTD.; ANVIFISH JOINT STOCK COMPANY (A/K/A ANVIFISH JSC); ASIA COMMERCE FISHERIES JOINT STOCK COMPANY (A/K/A ACOMFISH OR ACOMFISH JSC); BIEN DONG SEAFOOD CO., LTD.; BINH AN SEAFOOD JOINT STOCK CO.; CANTHO IMPORT-EXPORT SEAFOOD JOINT STOCK COMPANY (A/K/A CASEAMEX); EAST SEA SEAFOODS LIMITED LIABILITY COMPANY (A/K/A ESS LLC); EAST SEA SEAFOODS JOINT VENTURE CO., LTD.; HIEP THANH SEAFOOD JOINT STOCK CO.; SOUTHERN FISHERY INDUSTRIES COMPANY (A/K/A SOUTH VINA); OR VINH QUANG FISHERIES CORPORATION, AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 08/01/2009 THROUGH 07/31/2010. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE ISSUED.

4. THE INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS IN MESSAGE NUMBER 2103303 DATED 04/12/2012.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.
  
6. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 04/13/2012. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 04/13/2012.
