RE: Amended Preliminary injunction on TRBs from the People's Republic of China for the period 06/01/2009 through 05/31/2010 for Changshan Peer Bearing Company, Ltd. (A-570-601-028), court number 12-00039

1. ON 03/8/2012, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN AMENDED PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-601) FOR THE PERIOD 06/01/2009 THROUGH 05/31/2010.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 12-00039 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH 3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND EXPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA BY CHANGSHAN PEER BEARING CO., LTD. AND IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) PEER BEARING COMPANY OR WERE PRODUCED BY CHANGSHAN PEER BEARING CO., LTD. IN THE PEOPLE'S REPUBLIC OF CHINA AND EXPORTED FROM THAILAND BY PEER BEARING (THAILAND) CO., LTD. AND IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) PEER BEARING COMPANY AND WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 06/01/2009 THROUGH 05/31/2010. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE ISSUED.

NOTE: ENTRIES EXPORTED FROM THAILAND MAY HAVE ENTERED UNDER CASE NUMBER A-549-827.

4. THE AMENDED INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS IN

MESSAGE NUMBER 2046309 DATED 02/15/2012.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE-REFERENCED AMENDED INJUNCTION ON 03/09/2012. PURSUANT TO THE TERMS OF THE AMENDED INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE AMENDED INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 03/08/2012.
