RE: Out-of-scope preliminary determination - countervailing duty order on certain coated paper suitable for high-quality print graphics using sheet-fed presses from the PRC (C-570-959)

NOTICE OF THE LIFTING OF SUSPENSION OCCURRED ON THE MESSAGE DATE OF THESE INSTRUCTIONS. SEE PARAGRAPH 5 BELOW.

1. COMMERCE RECEIVED A SCOPE RULING REQUEST FROM GOLD EAST PAPER (JIANGSU) CO. LTD. (INCLUDING ITS SUBSIDIARIES NINGBO ZHONGHUA PAPER CO., LTD. AND NINGBO ASIA PULP AND PAPER CO., LTD.), GLOBAL PAPER SOLUTIONS, INC., PINDO DELI PULP AND PAPER MILLS, PT. INDAH KIAT PULP & PAPER TBK, AND PAPER MAX, LTD. (COLLECTIVELY "APP"). COMMERCE ISSUED A PRELIMINARY SCOPE DETERMINATION ON 02/02/2012 THAT APP'S GREY-CENTER PLAYING CARD BOARD AND BLACK-CENTER PLAYING CARD BOARD WHICH APP EXPORTS ARE NOT WITHIN THE SCOPE OF THE COUNTERVAILING DUTY ORDER ON CERTAIN COATED PAPER SUITABLE FOR HIGH-QUALITY PRINT GRAPHICS USING SHEET-FED PRESSES ("CERTAIN COATED PAPER") FROM THE PEOPLE'S REPUBLIC OF CHINA ("PRC") (C-570-959).

2. COMMERCE PRELIMINARILY DETERMINED THAT APP'S GREY- AND BLACK-CENTER PLAYING CARD BOARD ARE OUTSIDE THE SCOPE OF THE ORDER BECAUSE THEIR APPLICATIONS ARE NOT SIMILAR TO THE APPLICATIONS OF THE SUBJECT MERCHANDISE.

3. IN ACCORDANCE WITH 19 CFR 351.225(L)(2), EFFECTIVE 11/17/2010, CBP SHALL TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION OF APP'S GREY- AND BLACK-CENTER PLAYING CARD BOARD DESCRIBED IN PARAGRAPH 2.

4. REFUND ANY CASH DEPOSITS AND RELEASE ANY BONDS RELATING TO APP'S GREY- AND BLACK-CENTER PLAYING CARD BOARD DESCRIBED IN PARAGRAPH 2.

5. THESE INSTRUCTIONS CONSTITUTE NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF APP'S GREY- AND BLACK-CENTER PLAYING CARD BOARD

FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/17/2010.

6. THE ASSESSMENT OF COUNTERVAILING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930, AS AMENDED. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS OR ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED COUNTERVAILING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

7. UNLESS INSTRUCTED OTHERWISE, FOR ALL OTHER SHIPMENTS OF CERTAIN COATED PAPER FROM THE PRC NOT COVERED BY PARAGRAPH 2 ABOVE, YOU SHALL CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED COUNTERVAILING DUTIES FOR MERCHANDISE SUBJECT TO THE COUNTERVAILING DUTY ORDER AT THE CURRENT RATES.

8.
