3. SUBSEQUENTLY, CASE NUMBER A-570-868-004 WAS DELETED IN THE ACS MODULE. (CASE NUMBER A-570-868-000 WAS CREATED IN THE FINAL OF THE INVESTIGATION FOR THE PRC-WIDE ENTITY.)

4. IT IS NOT CERTAIN WHEN CASE NUMBER A-570-868-004 WAS DELETED FROM ACS , IT IS ALSO UNCERTAIN AS TO HOW LONG SUBJECT MERCHANDISE CONTINUED TO ENTER UNDER CASE NUMBER A-570-868-004.

5. HOWEVER, ENTRIES UNDER A-570-868-004 FOR THE PERIOD 12/03/2001 THROUGH 05/31/2003 SHOULD BE LIQUIDATED VIA MESSAGE 4189203 DATED 07/07/2004. MESSAGE 2025305, DATED 01/25/2012 (CORRECTING MESSAGE 7116212, DATED 04/26/2007), IS TO BE USED TO LIQUIDATE ENTRIES FOR THE 06/01/2004 THROUGH 05/31/2005 PERIOD OF REVIEW.
