RE: Amended Preliminary injunction on citric acid and certain citrate salts for RZBC and Yixing from China (A-570-937), 11/20/2008 - 4/30/2010, Ct. # 11-00536

1. ON JANUARY 6, 2012, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN AMENDED PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CITRIC ACID AND CERTAIN CITRATE SALTS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-937) FOR THE PERIOD 11/20/2008 THROUGH 4/30/2010.

2. THIS AMENDED INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 11-00536 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH 3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY RZBC CO., LTD.; RZBC IMP & EXP CO., LTD.; RZBC (JUXIAN) CO., LTD. (COLLECTIVELY, "RZBC") OR BY YIXING UNION BIOCHEMICAL CO., LTD., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 11/20/2008 THROUGH 04/30/2010. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE ISSUED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THE AMENDED INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER RECEIVED THE ABOVE-REFERENCED AMENDED INJUNCTION ON 01/12/2012.
