IN ITS AMENDED PRELIMINARY DETERMINATION OF SALES AT LESS THAN FAIR VALUE IN THE ANTIDUMPING DUTY INVESTIGATION OF CIRCULAR WELDED CARBON QUALITY STEEL PIPE FROM THE PEOPLE'S REPUBLIC OF CHINA (STEEL PIPE) (73 FR 22130, DATED 04/24/2008), COMMERCE DETERMINATED THAT JIANGSU YULONG STEEL PIPE CO., LTD. (YULONG) (A-570-910-032) WAS NOT ENTITLED TO A SEPARATE RATE AND IS PART OF THE PRC-WIDE ENTITY.

2. DUE TO DIFFERENT EFFECTIVE DATES OF SUSPENSION OF LIQUIDATION FOR YULONG AND THE PRC-WIDE ENTITY, RESULTING FROM THE DIFFERENT EFFECTIVE DATES OF THE PRELIMINARY AFFIRMATIVE CRITICAL CIRCUMSTANCES DETERMINATIONS FOR YULONG AND THE PRC-WIDE ENTITY, ENTRIES OF SUBJECT MERCHANDISE FROM YULONG CONTINUED TO BE SUSPENDED UNDER YULONG'S SEPARATE COMPANY PROFILE (A-570-910-032) IN THE ACS (SEE MESSAGE 8119201, DATED 04/29/2008).

3. COMMERCE NOW INTENDS TO INACTIVATE THE SEPARATE COMPANY PROFILE FOR YULONG (A-570-910-032). EFFECTIVE 12/09/2011 (THE DATE OF PUBLICATION OF THE RESCISSION OF REVIEW FEDERAL REGISTER NOTICE 76 FR 76944) ALL ENTRIES OF STEEL PIPE FROM CHINA EXPORTED BY YULONG SHOULD BE ENTERED UNDER A-570-910-000 AT THE PRC-WIDE RATE OF 85.55%.
