RE: Scope determination on antidumping duty order on wooden bedroom furniture from the People's Republic of China (A-570-890)

1. ON 12/13/2011, IN RESPONSE TO A REQUEST BY UNIVERSITY LOFT COMPANY, COMMERCE ISSUED A FINAL SCOPE DETERMINATION THAT UNIVERSITY LOFT COMPANY'S TWIN-SIZED METAL BED HEADBOARD (ITEM NUMBER 50470-12), FULL-SIZED METAL BED HEADBOARD (ITEM NUMBER 50480-12), AND UPPERCLASSMAN 2 SHELF NIGHTSTAND (ITEM NUMBER 50568-152), WHICH UNIVERSITY LOFT COMPANY IMPORTS, ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890).

2. BECAUSE THE IMPORTED PRODUCTS ARE SUBSTANTIALLY MADE OF WOOD (THE TWIN-SIZED AND FULL-SIZED BED HEADBOARDS AND THE NIGHTSTAND CONTAIN LAMINATED PARTICLEBOARD PANELS THAT ARE COMPOSED OF WOOD), COMMERCE FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING UNIVERSITY LOFT COMPANY'S TWIN-SIZED METAL BED HEADBOARD (ITEM NUMBER 50470-12), FULL-SIZED METAL BED HEADBOARD (ITEM NUMBER 50480-12), AND UPPERCLASSMAN 2 SHELF NIGHTSTAND (ITEM NUMBER 50568-152) IMPORTED BY UNIVERSITY LOFT COMPANY DESCRIBED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA.
