COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (76 FR 72676) ON 11/25/2011 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING DUTY ORDER ON POLYETHYLENE TEREPHTHALATE FILM, SHEET, AND STRIP FROM BRAZIL FOR THE PERIOD 11/01/2009 THROUGH 10/31/2010.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR A CERTAIN COMPANY. THEREFORE, FOR SHIPMENTS OF POLYETHYLENE TEREPHTHALATE FILM, SHEET, AND STRIP FROM BRAZIL ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/25/2011, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED AS LISTED IN THE COMPANY-DETAILS TABLE APPENDED TO THE BOTTOM OF THIS MESSAGE AND AS LISTED BELOW.

4. FOR ALL MANUFACTURERS/EXPORTERS OF POLYETHYLENE TEREPHTHALATE FILM, SHEET, AND STRIP FROM BRAZIL WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 28.72 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE COVERED BY THE ADMINISTRATIVE REVIEW UNTIL SPECIFIC LIQUIDATION INSTRUCTIONS ARE ISSUED.
