RE: Scope determination on countervailing duty (CVD) order on aluminum extrusions from the People's Republic of China (PRC) C-570-968.

1. ON 10/25/2011, IN RESPONSE TO A REQUEST BY RUBBERMAID COMMERCIAL PRODUCTS LLC (RUBBERMAID), COMMERCE ISSUED A FINAL SCOPE DETERMINATION THAT RUBBERMAID'S CLEANING SYSTEM COMPONENTS WHICH IT IMPORTS ARE WITHIN THE SCOPE OF THE CVD DUTY ORDER ON ALUMINUM EXTRUSIONS FROM THE PRC C-570-968.

2. THE DEPARTMENT FOUND THAT THE CLEANING SYSTEM COMPONENTS IMPORTED SEPARATELY, DO NOT MEET THE EXCLUSION FOR FINISHED GOOD KITS BECAUSE THEY DO NOT INCLUDE ALL COMPONENTS TO FORM A FINAL CLEANING DEVICE. ADDITIONALLY, THE DEPARTMENT FOUND THAT THE MOPPING KITS AT ISSUE, ONE TYPE OF CLEANING SYSTEM COMPONENTS WHICH RUBBERMAID IMPORTS, INCLUDE A TUBE, A TRIGGER HANDLE, A SOAP RESERVOIR, AND A WET/DRY FRAME ON WHICH DISPOSABLE MOPS ARE ATTACHED, BUT DO NOT INCLUDE A MOP END, WHICH THE DEPARTMENT FOUND, WAS REQUIRED IN ORDER TO MEET THE EXCLUSION FOR A FINISHED GOODS KIT. THEREFORE, THE DEPARTMENT FOUND THAT THE MERCHANDISE IS WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF CLEANING SYSTEM COMPONENTS FROM THE PRC, INCLUDING RUBBERMAID'S CLEANING SYSTEM COMPONENTS IMPORTED BY RUBBERMAID AS DESCRIBED ABOVE, SUBJECT TO THE CVD DUTY ORDER ON ALUMINUM EXTRUSIONS FROM THE PRC.
