RE: Diamond Sawblades and Parts Thereof from the Republic of Korea (A-580-855) – No Cash Deposit Required

1. COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA (A-580-855) BUT IS INSTRUCTING CBP TO CONTINUE THE SUSPENSION OF LIQUIDATION OF ENTRIES OF DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA WITHOUT A CASH DEPOSIT AS SPECIFIED BELOW.

2. ON 10/28/2011, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER THE FINAL RESULTS OF THE SECTION 129 DETERMINATION ON DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA (76 FR 66892). AS A RESULT OF THIS DETERMINATION, COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA. THE EFFECTIVE DATE OF THE REVOCATION IS 10/24/2011.

3. ALTHOUGH COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER, IN ACCORDANCE WITH THE TEMPORARY RESTRAINING ORDER AND PRELIMINARY INJUNCTION ISSUED BY THE COURT OF INTERNATIONAL TRADE ON 10/13/2011 AND 10/24/2011, RESPECTIVELY (SEE MESSAGES 1293301, DATED 10/20/2011 AND 1301306, DATED 10/28/2011), UNTIL INSTRUCTED OTHERWISE, CBP IS DIRECTED TO SUSPEND OR CONTINUE TO SUSPEND LIQUIDATION OF ALL ENTRIES OF SUBJECT MERCHANDISE FROM THE REPUBLIC OF KOREA WHICH ARE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/23/2009.

4. FOR ENTRIES OF DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER THE EFFECTIVE DATE OF THE REVOCATION NOTICE, 10/24/2011, CBP IS INSTRUCTED TO CONTINUE THE SUSPENSION OF LIQUIDATION OF SUCH ENTRIES WITHOUT A CASH DEPOSIT. SEE COMMERCE'S NOTICE OF REVOCATION, 76 FR 66892.
