RE: Preliminary injunction on automotive wheel hub assemblies containing TRBs imported by Power Train Components, Inc., from the PRC for the period 6/30/2009 - 5/31/2010 (A-570-601), court number 11-00153

1. ON 10/18/2011, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-601) FOR THE PERIOD 6/30/2009 THROUGH 5/31/2010.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 11-00153 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH 3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF AUTOMOTIVE WHEEL HUB ASSEMBLIES CONTAINING TAPERED ROLLER BEARINGS, FROM THE PEOPLE'S REPUBLIC OF CHINA: (1) WHOSE IMPORTER OF RECORD IS POWER TRAIN COMPONENTS, INC., AND (2) WHICH WERE ENTERED DURING THE PERIOD COMMENCING ON 06/30/2009 AND ENDING 05/31/2010. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE ISSUED.

4. THE INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS IN MESSAGE NUMBER 0260312, DATED 09/17/2010.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 10/19/2011. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 10/18/2011.
