1. ON 10/19/2011, COMMERCE PUBLISHED IN THE FEDERAL REGISTER (76 FR 64898) ITS FINAL RESULTS IN THE CHANGED CIRCUMSTANCES REVIEW OF THE ANTIDUMPING DUTY ORDER ON DIAMOND SAWBLADES AND PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-900).

2. COMMERCE FOUND THAT HEBEI HUSQVARNA-JIKAI DIAMOND TOOLS CO., LTD. DID NOT DEMONSTRATE THAT IT WAS MATERIALLY SIMILAR TO HEBEI JIKAI INDUSTRIAL GROUP CO., LTD. COMMERCE THEREFORE DETERMINED THAT HEBEI HUSQVARNA-JIKAI DIAMOND TOOLS CO., LTD. IS NOT THE SUCCESSOR-IN-INTEREST TO HEBEI JIKAI INDUSTRIAL GROUP CO., LTD., AND THEREFORE IS NOT ENTITLED TO USE HEBEI JIKAI INDUSTRIAL GROUP CO., LTD.'S CASH DEPOSIT RATE.

3. ACCORDINGLY, FOR SHIPMENTS OF DIAMOND SAWBLADES AND PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 10/19/2011, CBP SHALL REQUIRE A CASH DEPOSIT FOR ESTIMATED ANTIDUMPING DUTIES AT THE FOLLOWING RATE:
