1. ON 10/13/2011 THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A TEMPORARY RESTRAINING ORDER (TRO) ENJOINING THE LIFTING OF SUSPENSION OF LIQUIDATION REGARDING INCOMING ENTRIES OF DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA, AND/OR MAKING OR PERMITTING LIQUIDATION OF ANY UNLIQUIDATED ENTRIES OF CERTAIN DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA, WHICH ARE SUBJECT TO THE FINAL RESULTS OF THE LESS-THAN-FAIR-VALUE INVESTIGATION PUBLISHED AT DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA, 71 FR 29310 (MAY 22, 2006).

2. THIS TRO WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00248 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE. THIS TRO SHALL BE EFFECTIVE FOR ALL ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. ON 10/21/2011 AND SHALL REMAIN IN EFFECT UNTIL 11/03/2011.

3. ACCORDINGLY, EFFECTIVE 10/21/2011 AND UNTIL 11/03/2011, CBP IS INSTRUCTED NOT TO LIQUIDATE ENTRIES OF MERCHANDISE SUBJECT TO THE TRO AS DESCRIBED IN PARAGRAPH 1. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY (INCLUDING ENTRIES COVERED BY MESSAGE 1020304 DATED 01/20/2011). CONTINUE TO SUSPEND LIQUIDATION ALL ENTRIES OF DIAMOND SAWBLADES AND PARTS THEREOF FROM THE REPUBLIC OF KOREA THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/23/2009 UNTIL LIQUIDATION INSTRUCTIONS ARE ISSUED.
