RE: INJUNCTION ON CERTAIN NEW PNEUMATIC OFF-THE-ROAD TIRES FROM CHINA IMPORTED BY OTR WHEEL ENGINEERING, INC. (A-570-912, C-570-913), COURT # 11-00166

1. ON 09/30/2011, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING AND COUNTERVAILING DUTY ORDERS ON CERTAIN NEW PNEUMATIC OFF-THE-ROAD TIRES FROM CHINA (A-570-912, C-570-913).

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 11-CV-00166 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE THAT (1) WERE IMPORTED BY OTR WHEEL ENGINEERING, INC.; (2) WERE SUBJECT TO THE APRIL 26, 2011, SCOPE RULING OF THE DEPARTMENT OF COMMERCE REGARDING THE ANTIDUMPING AND COUNTERVAILING DUTY ORDERS ON CERTAIN NEW PNEUMATIC OFF-THE-ROAD TIRES FROM THE PEOPLE'S REPUBLIC OF CHINA (SEE CBP MESSAGES 1137302 AND 1137303, DATED 05/17/2011); (3) CONSIST OF TRAC MASTER AND/OR TRACTION MASTER TIRES AS DESCRIBED IN THAT SCOPE RULING; AND (4) REMAIN UNLIQUIDATED AS OF 5 P.M. ON 09/30/2011.

ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. EFFECTIVE IMMEDIATELY, U.S. CUSTOMS AND BORDER PROTECTION (CBP) IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

5. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 09/30/2011. PURSUANT TO THE TERMS OF THIS INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THIS INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5 P.M. ON 09/30/2011, THE DAY ON
