1. FOR ALL SHIPMENTS OF WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA EXPORTED BY THE PRC-WIDE ENTITY (A-570-890-000), ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 01/01/2009 THROUGH 12/31/2009, ASSESS AN ANTIDUMPING LIABILITY EQUAL TO 216.01 PERCENT OF THE ENTERED VALUE.

2. IN THE DEPARTMENT'S FINAL RESULTS (76 FR 49729, 08/11/2011) THE DEPARTMENT DETERMINED THAT THE FOLLOWING EXPORTERS ARE NO LONGER ELIGIBLE FOR A SEPARATE RATE AND ARE CONSIDERED PART OF THE PRC ENTITY.

CONSUMPTION DURING THE PERIOD 01/01/2009 THROUGH 12/31/2009, SHOULD BE LIQUIDATED IN ACCORDANCE WITH THE ASSESSMENT INSTRUCTIONS LISTED IN PARAGRAPH 1 ABOVE FOR THE PRC ENTITY. ENTRIES OF SUCH MERCHANDISE MAY HAVE ENTERED UNDER THE CASE NUMBERS LISTED ABOVE.

3. THE NOTICE OF LIFTING OF SUSPENSION OF LIQUIDATION FOR ENTRIES OF SUBJECT MERCHANDISE DURING THE PERIOD 01/01/2009 THROUGH 12/31/2009, OCCURRED WITH THE PUBLICATION OF THE AMENDED FINAL RESULTS OF ADMINISTRATIVE REVIEW (76 FR 57713, 09/16/2011). FOR ALL OTHER SHIPMENTS OF WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT CASH DEPOSIT RATES OR PER-UNIT AMOUNTS.

4. THE INJUNCTION WITH COURT NUMBER 10-00352, IN MESSAGE NUMBER 0362304, DATED 12/28/2010, IS APPLICABLE TO ENTRIES OF THE HERITAGE COURT BENCH (MODEL 800-4800) WHICH WERE IMPORTED BY LEGACY CLASSIC FURNITURE, INC. ACCORDINGLY, UNTIL FURTHER NOTICE, CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

IN ADDITION, THE INJUNCTION WITH COURT NUMBER 11-00325, IN MESSAGE NUMBER 1245309, DATED 09/02/2011, IS APPLICABLE TO THE ENTRIES OF SUBJECT MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE , FOR CONSUMPTION DURING THE PERIOD 01/01/2009 THROUGH 12/31/2009 WHICH WAS EXPORTED BY DALIAN HUAFENG FURNITURE CO., LTD./DALIAN HUAFENG FURNITURE GROUP CO., LTD, AND IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA INTO THE UNITED STATES BY HOME MERIDIAN INTERNATIONAL, INC. D/B/A SAMUEL LAWRENCE FURNITURE CO. AND PULASKI FURNITURE COMPANY OR EXPORTED BY DALIAN HUAFENG FURNITURE CO., LTD./DALIAN HUAFENG FURNITURE GROUP CO., LTD. AND IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA INTO THE UNITED STATES BY IMPORT SERVICES, INC. ACCORDINGLY, UNTIL FURTHER NOTICE, CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. DURING THE PERIOD OF REVIEW, DALIAN HUAFENG FURNITURE CO., LTD. (A-570-890-011) CHANGED ITS NAME TO DALIAN HUAFENG FURNITURE GROUP CO., LTD. THUS ENTRIES MAY HAVE ENTERED UNDER A-570-890-000.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF

ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. UPON ASSESSMENT OF ANTIDUMPING DUTIES, CBP SHOULD REQUIRE THAT THE IMPORTER PROVIDE A REIMBURSEMENT STATEMENT AS DESCRIBED IN SECTION 351.402(F)(2) OF COMMERCE'S REGULATIONS. THE IMPORTER SHOULD PROVIDE THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION OF THE ENTRY. IF THE IMPORTER CERTIFIES THAT IT HAS AN AGREEMENT WITH THE MANUFACTURER, PRODUCER, SELLER, OR EXPORTER, TO BE REIMBURSED ANTIDUMPING DUTIES, CBP SHOULD DOUBLE THE ANTIDUMPING DUTIES IN ACCORDANCE WITH THE ABOVE-REFERENCED REGULATION. ADDITIONALLY, IF THE IMPORTER DOES NOT PROVIDE THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION, CBP SHOULD PRESUME REIMBURSEMENT AND DOUBLE THE ANTIDUMPING DUTIES DUE.
