BECAUSE THE IMPORTED PRODUCTS ARE COMPOSED OF NARROW WOVEN RIBBON WITH A WOVEN SELVEDGE, MEASURING LESS THAN 12 CENTIMETERS IN WIDTH; CONSTRUCTED OF, IN WHOLE OR IN PART, MAN-MADE FIBERS; COMPOSED OF NARROW WOVEN RIBBON WITH EMBELLISHMENTS; AND DO NOT FALL WITHIN THE EXCLUSIONS AS DESCRIBED BY THE SCOPE OF THE COUNTERVAILING DUTY ORDER, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF NARROW WOVEN RIBBONS WITH WOVEN SELVEDGE FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING O&L INC.'S TRIMMINGS LISTED ABOVE, SUBJECT TO THE COUNTERVAILING DUTY ORDER COVERING NARROW WOVEN RIBBONS WITH WOVEN SELVEDGE FROM THE PEOPLE'S REPUBLIC OF CHINA.
