COMMERCE HAS AMENDED THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF ANTIDUMPING DUTY ORDER ON CERTAIN LINED PAPER PRODUCTS FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 04/17/2006 THROUGH 08/31/2007.
