RE: LIQUIDATION INSTRUCTIONS FOR 1-HYDROXYETHYLIDENE-1, 1-DIPHOSPHONIC ACID FROM THE PRC EXPORTED BY THE PRC-WIDE ENTITY FOR THE PERIOD 04/23/2009 THROUGH 03/31/2010 (A-570-934)

1. FOR ALL SHIPMENTS OF 1-HYDROXYETHYLIDENE-1, 1-DIPHOSPHONIC ACID FROM THE PEOPLE'S REPUBLIC OF CHINA EXPORTED BY THE PEOPLE'S REPUBLIC OF CHINA-WIDE ENTITY (A-570-934-000) ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 04/23/2009 THROUGH 03/31/2010, ASSESS AN ANTIDUMPING LIABILITY EQUAL TO 72.42 PERCENT OF THE ENTERED VALUE.

2. IN THE DEPARTMENT'S FINAL RESULTS (76 FR 48142, 08/08/2011), THE DEPARTMENT DETERMINED THAT THE FOLLOWING EXPORTER IS NO LONGER ELIGIBLE FOR A SEPARATE RATE AND IS CONSIDERED PART OF THE PRC ENTITY:

EXPORTER: JIANGSU JIANGHAI CHEMICAL GROUP CO., LTD.

THEREFORE, ENTRIES OF 1-HYDROXYETHYLIDENE-1, 1-DIPHOSPHONIC ACID EXPORTED BY THE FIRMS LISTED IN THIS PARAGRAPH, ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 04/23/2009 THROUGH 03/31/2010, SHOULD BE LIQUIDATED IN ACCORDANCE WITH THE ASSESSMENT INSTRUCTIONS LISTED IN PARAGRAPH 1 ABOVE FOR THE PRC ENTITY. ENTRIES OF SUCH MERCHANDISE MAY HAVE ENTERED UNDER THE FOLLOWING CASE NUMBER:

3. THE NOTICE OF LIFTING OF SUSPENSION OF LIQUIDATION FOR ENTRIES OF SUBJECT MERCHANDISE DURING THE PERIOD 04/23/2009 THROUGH 03/31/2010 OCCURRED WITH THE PUBLICATION OF THE FINAL RESULTS OF ADMINISTRATIVE REVIEW (76 FR 48142, 08/08/2011). FOR ALL OTHER SHIPMENTS OF 1-HYDROXYETHYLIDENE-1, 1-DIPHOSPHONIC ACID FROM THE PEOPLE'S REPUBLIC OF CHINA, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE

CURRENT CASH DEPOSIT RATES.

4. THERE ARE NO INJUNCTIONS APPLICABLE TO THE ENTRIES COVERED BY THIS INSTRUCTION.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. UPON ASSESSMENT OF ANTIDUMPING DUTIES, CBP SHOULD REQUIRE THAT THE IMPORTER PROVIDE A REIMBURSEMENT STATEMENT AS DESCRIBED IN SECTION 351.402(F)(2) OF COMMERCE'S REGULATIONS. THE IMPORTER SHOULD PROVIDE THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION OF THE ENTRY. IF THE IMPORTER CERTIFIES THAT IT HAS AN AGREEMENT WITH THE MANUFACTURER, PRODUCER, SELLER, OR EXPORTER, TO BE REIMBURSED ANTIDUMPING DUTIES, CBP SHOULD DOUBLE THE ANTIDUMPING DUTIES IN ACCORDANCE WITH THE ABOVE-REFERENCED REGULATION. ADDITIONALLY, IF THE IMPORTER DOES NOT PROVIDE THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION, CBP SHOULD PRESUME REIMBURSEMENT AND DOUBLE THE ANTIDUMPING DUTIES DUE.
