ON 08/22/2011, THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER (76 FR 52315) THE RESCISSION OF THE NEW SHIPPER REVIEWS OF THE ANTIDUMPING DUTY ORDER ON FRESH GARLIC FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE EXPORTERS SHENZHEN BAINONG CO., LTD. (A-570-831-053) AND JINING YIFA GARLIC PRODUCE CO., LTD. (A-570-831-055) FOR THE PERIOD 11/01/2009 THROUGH 04/30/2010.

THE PRC-WIDE RATE IN EFFECT IS \$4.71 PER KILOGRAM.
