5. If a bond or cash deposit was collected as security for an estimated countervailing duty for any shipment of merchandise described in paragraphs 2a. and 2b. that was entered, or withdrawn from warehouse, for consumption during the period 09/07/2010 through 01/05/2011, assess countervailing duties equal to the amount resulting from application of paragraphs 2a. and 2b. or equal to the amount of the bond or cash deposit, whichever is less.

6. The injunction with court number 13-00161 discussed in message number 3150302 dated 05/30/2013 is applicable to the entries of dock ladder kits ASE, ASH, and DJX3-W imported by Asia Sourcing Corporation and strip door mounting brackets imported by Asia Sourcing Corporation, and which were entered, or withdrawn from warehouse, for consumption by Asia Sourcing Corporation on or after 09/07/2010.

9. The injunction with court number 13-00238 discussed in message number 3199306, dated 07/18/2013, is applicable to certain entries produced by Zhangjiagang GuPai Aluminum Industry Co. and exported by Snap On Trading Shanghai Ltd. during the period 05/31/2011 through 03/12/2012.

Accordingly, continue to suspend liquidation of such entries until liquidation instructions are issued.

10. The assessment of countervailing duties by the CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated countervailing duties. The interest provisions are not applicable to cash or bonds posted as estimated countervailing duties before the date of publication of the countervailing duty order. Interest shall be calculated from the date of payment of estimated countervailing duties through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.

11. The suspension of liquidation ordered for this merchandise entered on or after 09/07/2010 and on or before 12/31/2011 is lifted. Unless instructed otherwise, suspension of liquidation for all entries of this merchandise entered or withdrawn from warehouse, for consumption after 12/31/2011 will continue.
