RE: FINAL SCOPE RULING ON ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED OR UNFINISHED, FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-601)

1. ON 08/03/2011, IN RESPONSE TO A REQUEST BY DF MACHINERY INTERNATIONAL, INC., COMMERCE ISSUED A FINAL SCOPE RULING THAT AGRICULTURAL HUB UNITS, THAT INCORPORATE TAPERED ROLLER BEARINGS, IMPORTED BY DF MACHINERY INTERNATIONAL, INC., ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED OR UNFINISHED, FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-601).

2. BECAUSE AGRICULTURAL HUB UNITS THAT CONTAIN TAPERED ROLLER BEARINGS IMPORTED BY DF MACHINERY INTERNATIONAL, INC. MEET THE DESCRIPTION OF THE MERCHANDISE INCLUDED IN THE PETITION, THE INTERNATIONAL TRADE COMMISSION REPORT, THE SCOPE OF THE ORDER, AND PRIOR SCOPE RULINGS, COMMERCE FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF TAPERED ROLLER BEARINGS FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING AGRICULTURAL HUB UNITS INCORPORATING TAPERED ROLLER BEARINGS IMPORTED BY DF MACHINERY INTERNATIONAL, INC., SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED OR UNFINISHED, FROM THE PEOPLE'S REPUBLIC OF CHINA.
