RE: Preliminary injunction on certain frozen warmwater shrimp from Vietnam for Grobest & I-Mei Industrial (Vietnam) Co., Ltd. for the period 02/01/2008 through 01/31/2009 (A-552-802), court number 14-0009

1. On 04/11/2014, the U.S. Court of International Trade issued a preliminary injunction enjoining liquidation of certain entries which are subject to the antidumping duty order on certain frozen warmwater shrimp from the Socialist Republic of Vietnam (A-552-802) for the period 02/01/2008 through 01/31/2009.
2. This injunction was issued in connection with court case number 14-00092 and enjoins liquidation of the entries described in paragraph 3 below.
3. Accordingly, until further notice, do not liquidate entries of subject merchandise which were exported by Grobest & I-Mei Industrial (Vietnam) Co., Ltd., that were subject to the administrative determination in Certain Frozen Warmwater Shrimp from the Socialist Republic of Vietnam; Final Results of Re-conducted Administrative Review of Grobest & I-Mei Industrial (Vietnam) Co., Ltd. and Intent Not to Revoke; 2008-2009, 79 FR 15309 (Mar. 19, 2014), and which were entered, or withdrawn from warehouse, for consumption during the period 02/01/2008 through 01/31/2009. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.
4. Liquidation instructions for entries affected by the injunction have not yet been issued.
5. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.
6. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of 04/11/2014.
