RE: CASH DEPOSIT INSTRUCTIONS FOR CITRIC ACID AND CERTAIN CITRATE SALTS FROM CANADA (A-122-853)

1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (76 FR 34044) ON 06/10/2011 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON CITRIC ACID AND CERTAIN CITRATE SALTS FROM CANADA FOR THE PERIOD 11/20/2008 THROUGH 05/19/2009 AND 05/29/2009 THROUGH 04/30/2010.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR SHIPMENTS OF CITRIC ACID AND CERTAIN CITRATE SALTS FROM CANADA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/10/2011, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED, AS INDICATED IN THE TABLE ATTACHED BELOW.

3. IF ANY ENTRIES OF MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE TO DETERMINE THE CASH DEPOSIT RATE.

B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE, BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.

C. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE OR THE MANUFACTURER IS UNKNOWN, USE THE ALL-OTHERS RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

4. FOR ALL MANUFACTURERS/EXPORTERS OF CITRIC ACID AND CERTAIN CITRATE SALTS FROM CANADA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 23.21

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
