1. THIS MESSAGE RELATES TO MESSAGE NUMBER 1139303 DATED 05/19/2011.
2. ON 05/13/2011, THE U.S. COURT OF INTERNATIONAL TRADE ("CIT") ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON HONEY FROM THE PEOPLE'S REPUBLIC OF CHINA ("PRC") A-570-863, SUBSEQUENTLY, ON 05/24/2011, THE CIT ISSUED AN ORDER AMENDING THE PRELIMINARY INJUNCTION.
3. SPECIFICALLY, THIS INSTRUCTION AMENDS THE RE: LINE AND PARAGRAPHS #1 AND #3 IN MESSAGE 1139303, DATED 05/19/2011. IN THAT MESSAGE THE CIT ENJOINED ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND EXPORTED BY SUZHOU SHANDING HONEY PRODUCT CO., LTD. OR WUHU FENGLIAN CO., LTD., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 12/01/2008 THROUGH 11/30/2009. HOWEVER, THE AMENDED ORDER OF INJUNCTION ENJOINS ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND EXPORTED BY SUZHOU SHANDING HONEY PRODUCT CO., LTD. OR WUHU FENGLIAN CO., LTD., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 12/01/2008 THROUGH 12/30/2009.
4. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND EXPORTED BY SUZHOU SHANDING HONEY PRODUCT CO., LTD. OR WUHU FENGLIAN CO., LTD., AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 12/01/2008 THROUGH 12/30/2009. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

5. THIS INJUNCTION APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY MESSAGE NUMBER 1041302, DATE 02/10/2011.
6. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE CIT'S AMENDED ORDER, COVERING THE PERIOD 12/01/2008 THROUGH 12/30/2009.
7. COMMERCE WAS SERVED WITH THE ABOVE REFERENCED AMENDED INJUNCTION ON 5/24/2011. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE AS OF 5/13/2011.
