THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (76 FR 27988) ON 05/13/2011 THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN CASED PENCILS FROM PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 12/01/2008 THROUGH 11/30/2009.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN EXPORTERS.
