RE: PRELIM SCOPE RULING ON THE ANTIDUMPING DUTY ORDERS ON CARBAZOLE VIOLET PIGMENT 23 (CVP 23) FROM THE PRC(A-570-892) & INDIA(A-533-838) AND THE COUNTERVAILING DUTY ORDER ON CVP 23 FROM INDIA(C-533-839)

1. ON 05/06/2011, IN RESPONSE TO A REQUEST BY NATION FORD CHEMICAL COMPANY AND SUN CHEMICAL CORPORATION, COMMERCE ISSUED A PRELIMINARY SCOPE RULING THAT CRUDE CVP 23 FROM THE PEOPLE'S REPUBLIC OF CHINA AND INDIA CONVERTED INTO FINISHED CVP 23 IN JAPAN BY TOYO INK MFG. CO., LTD. IS WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CVP 23 FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-892), THE ANTIDUMPING DUTY ORDER COVERING CVP 23 FROM INDIA (A-533-838), AND THE COUNTERVAILING DUTY ORDER COVERING CVP 23 FROM INDIA (C-533-839).
2. BECAUSE COMMERCE FOUND THE PROCESSING OF CRUDE CVP 23 FROM THE PEOPLE'S REPUBLIC OF CHINA AND INDIA INTO FINISHED CVP 23 IN JAPAN BY TOYO INK MFG. CO., LTD. DOES NOT CONSTITUTE SUBSTANTIAL TRANSFORMATION, COMMERCE PRELIMINARILY FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF ANTIDUMPING AND COUNTERVAILING DUTY ORDERS. CVP 23 FINISHED IN JAPAN BY TOYO INK MFG. CO., LTD. MAY CONSIST OF COMMINGLED CHINESE AND INDIAN CRUDE, MAY BE PURELY CHINESE IN ORIGIN, OR MAY BE PURELY INDIAN IN ORIGIN.
3. THEREFORE, THE QUANTITY OF CVP 23 ORIGINATING FROM THE PEOPLE'S REPUBLIC OF CHINA IS SUBJECT TO ANTIDUMPING DUTIES UNDER A-570-892 BASED ON THE ENTERED VALUE OF THAT QUANTITY AT THE PREVAILING RATE(S) IN EFFECT FOR THE CHINESE MANUFACTURER(S) WHICH PRODUCED THE CRUDE CVP 23.
4. IN ADDITION, THE QUANTITY OF CVP 23 ORIGINATING FROM INDIA IS SUBJECT TO ANTIDUMPING DUTIES UNDER A-533-838 AND COUNTERVAILING DUTIES UNDER C-533-839 BASED ON THE ENTERED VALUE OF THAT QUANTITY AT THE PREVAILING RATE(S) IN EFFECT FOR THE INDIAN MANUFACTURER(S) WHICH PRODUCED THE CRUDE CVP 23.

5. IF THE ORIGIN OF THE CVP 23 CANNOT BE ACCURATELY DETERMINED, THEN THE

ENTIRE SHIPMENT IS SUBJECT TO ANTIDUMPING DUTIES AT THE PREVAILING RATE FOR THE PRC-WIDE ENTITY (A-570-892-000).

6. EFFECTIVE 06/24/2010, SUSPEND LIQUIDATION OF ENTRIES OF CVP 23 PROCESSED INTO FINISHED CVP 23 IN JAPAN BY TOYO INK MFG. CO., LTD. FROM CRUDE CVP 23 ORIGINATING FROM THE PEOPLE'S REPUBLIC OF CHINA AND INDIA, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING CVP 23 FROM THE PEOPLE'S REPUBLIC OF CHINA, THE ANTIDUMPING DUTY ORDER ON CVP 23 FROM INDIA, AND THE COUNTERVAILING DUTY ORDER ON CVP 23 FROM INDIA, AS APPLICABLE.
