RE: PRELIMINARY INJUNCTION ON CERTAIN STEEL NAILS FOR THE STANLEY WORKS (LANGFANG) FASTENING SYSTEMS CO., LTD. FROM THE PRC FOR 01/23/2008 THROUGH 07/31/2009, (A-570-909) CT NO. 11-00102

1. ON 05/06/2011, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN STEEL NAILS FROM THE PEOPLE'S REPUBLIC OF CHINA A-570-909, FOR THE PERIOD 01/23/2008 THROUGH 07/31/2009.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 11-00102 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY THE STANLEY WORKS (LANGFANG) FASTENING SYSTEMS CO., LTD. AND WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 01/23/2008 THROUGH 07/31/2009. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE REFERENCED INJUNCTION ON 05/11/2011. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 PM ON THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED ON
