RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890)

1. ON 03/31/2011, IN RESPONSE TO A REQUEST BY POUNDEX ASSOCIATES CORP. ("POUNDEX"), COMMERCE ISSUED A FINAL SCOPE RULING THAT POUNDEX'S BI-CAST LEATHER SLEIGH BEDS (ITEM NUMBERS F9136Q, F9136CK, AND F9136EK) AND BI-CAST LEATHER PLATFORM BED (ITEM NUMBER F9117) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890).
2. BECAUSE THE IMPORTED PRODUCTS ARE SUBSTANTIALLY MADE OF WOOD (THE HEADBOARD AND FOOTBOARD FRAMES AND THE SIDE RAILS ARE COMPOSED OF WOOD), AND THE BEDS DO NOT MEET THE SCOPE EXCLUSION FOR COMPLETELY UPHOLSTERED BEDS, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.
3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING POUNDEX'S BI-CAST LEATHER SLEIGH BEDS (ITEM NUMBERS F9136Q, F9136CK, AND F9136EK) AND BI-CAST LEATHER PLATFORM BED (ITEM NUMBER F9117) LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA.
