1. ON 04/01/2011, THE COURT OF INTERNATIONAL TRADE ISSUED AN AMENDED PRELIMINARY INJUNCTION IN SHAOXING XIANGYU GREEN PACKING CO., LTD., V. UNITED STATES, CT. NO 11-00063, AMENDING THE ORIGINAL INJUNCTION ISSUED BY THE COURT ON 03/25/2011 TO WHICH MESSAGE 1087307 REFERS. IN RESPONSE TO THE COURT'S AMENDED PRELIMINARY INJUNCTION, COMMERCE IS CORRECTING PARAGRAPH 3 IN MESSAGE 1087307 DATED 03/28/2011.

2. PARAGRAPH 3 OF MESSAGE 1087307, THE DEPARTMENT STATED THAT ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY SHAOXING XIANGYU GREEN PACKING CO., LTD. ARE ENJOINED FROM LIQUIDATION. PARAGRAPH 3 SHOULD ONLY STATE THAT ENTRIES EXPORTED BY SHAOXING XIANGYU GREEN PACKING CO., LTD. ARE ENJOINED FROM LIQUIDATION.

3. PARAGRAPH 3 OF MESSAGE 1087307 CURRENTLY READS AS FOLLOWS:

ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE PRODUCED AND/OR EXPORTED BY SHAOXING XIANGYU GREEN PACKING CO., LTD., AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 11/06/2008 THROUGH 10/31/2009. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. INSTEAD, PARAGRAPH 3 OF MESSAGE 1087307 SHOULD READ AS FOLLOWS:

ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY SHAOXING XIANGYU GREEN PACKING CO., LTD., AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING

THE PERIOD 11/06/2008 THROUGH 10/31/2009. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
