1. ON 03/01/2011 THE U.S. COURT OF INTERNATIONAL TRADE (CIT) GRANTED A TEMPORARY RESTRAINING ORDER (TRO) ENJOINING U. S. CUSTOMS AND BORDER PROTECTION FROM ALLOWING THE FINALIZATION OF LIQUIDATION AND TAKING ANY ADMINISTRATIVE ACTION, INCLUDING COLLECTION OF DUTIES, PURSUANT TO THE LIQUIDATION OF ENTRIES LISTED BELOW IMPORTED BY UNITED SUPPLY CORP. WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD DECEMBER 1, 2007 THROUGH NOVEMBER 30, 2008.
