WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-827) FOR THE PERIOD 12/01/2007 THROUGH 11/30/2008.

REPUBLIC OF CHINA UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
