RE: PRELIMINARY SCOPE RULING ON ANTIDUMPING DUTY ORDER ON WHEEL HUB ASSEMBLIES/UNITS INCORPORATING TAPERED ROLLER BEARINGS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-601)

1. ON 12/13/2010, IN RESPONSE TO A REQUEST BY NEW TREND ENGINEERING LTD., COMMERCE ISSUED A PRELIMINARY SCOPE RULING THAT WHEEL HUB ASSEMBLIES/UNITS IMPORTED AND EXPORTED BY NEW TREND ENGINEERING LTD., BOTH WITH AND WITHOUT ANTILOCK BRAKING SYSTEMS, THAT INCORPORATE TAPERED ROLLER BEARINGS, ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED OR UNFINISHED, FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-601).

2. BECAUSE WHEEL HUB ASSEMBLIES IMPORTED AND EXPORTED BY NEW TREND LTD. WITHOUT ANTILOCK BRAKING SYSTEM ELEMENTS THAT CONTAIN TAPERED ROLLER BEARINGS MEET THE DESCRIPTION OF THE MERCHANDISE INCLUDED IN THE SCOPE OF THE PETITION, THE INTERNATIONAL TRADE COMMISSION REPORT, AND THE SCOPE OF THE ORDER, COMMERCE PRELIMINARILY FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER. BECAUSE WHEEL HUB ASSEMBLIES IMPORTED AND EXPORTED BY NEW TREND LTD. WITH ANTILOCK BRAKING SYSTEM ELEMENTS THAT CONTAIN TAPERED ROLLER BEARINGS (1) MEET THE PHYSICAL DESCRIPTION OF PRODUCTS COVERED UNDER THE ORDER; (2) SHARE THE SAME ESSENTIAL CUSTOMER EXPECTATIONS AND USE FOR PRODUCTS COVERED UNDER THE ORDER; AND (3) ARE SOLD THROUGH THE SAME CHANNELS OF TRADE AS PRODUCTS SUBJECT TO THE ORDER, COMMERCE PRELIMINARILY FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF TAPERED ROLLER BEARINGS FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING WHEEL HUB ASSEMBLIES/UNITS IMPORTED AND EXPORTED BY NEW TREND, BOTH WITH AND WITHOUT ANTILOCK BRAKING SYSTEMS INCORPORATING TAPERED ROLLER BEARINGS, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED OR UNFINISHED, FROM THE PEOPLE'S REPUBLIC OF CHINA.
