1. ON 01/11/2011, COMMERCE PUBLISHED IN THE FEDERAL REGISTER ITS FINAL DETERMINATION OF SALES AT NOT LESS THAN FAIR VALUE IN THE ANTIDUMPING DUTY INVESTIGATION OF DRILL PIPE FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) (76 FR 1966).

2. COMMERCE FOUND THAT NO FINAL MARGIN EXISTS WITH RESPECT TO IMPORTS OF DRILL PIPE FROM THE PRC THAT WERE EXPORTED AND MANUFACTURED BY THE FOLLOWING EXPORTER/MANUFACTURER COMBINATIONS.

INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
