RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON STEEL NAILS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-909)

1. ON 12/22/2010, IN RESPONSE TO A REQUEST BY MAZEL & CO., INC. (MAZEL), COMMERCE ISSUED A FINAL SCOPE RULING THAT CERTAIN STEEL ROOFING NAILS IMPORTED BY MAZEL ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING STEEL NAILS FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) (A-570-909). THE STEEL NAILS IMPORTED BY MAZEL THAT HAVE SHAFT LENGTHS LONGER THAN 1.75" AND/OR HEAD DIAMETER MEASUREMENTS BETWEEN 0.375" AND 0.394" ARE DETERMINED TO BE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING STEEL NAILS FROM THE PRC.
2. BECAUSE THE IMPORTED PRODUCT HAS THE SAME PHYSICAL CHARACTERISTICS THAT MEET THE PHYSICAL DESCRIPTION OF STEEL NAILS SUBJECT TO THE ORDER AND BECAUSE THE IMPORTED PRODUCT DOES NOT MEET THE MEASUREMENTS AND - 10% TOLERANCE OUTLINED IN THE ASTM STANDARD F 1667 (2005 REVEISION) FOR TYPE 1, STYLE 20 STEEL NAILS, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.
3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF STEEL NAILS FROM THE PRC, INCLUDING MAZEL'S GAP ROOFING NAILS LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING STEEL NAILS FROM THE PRC.
4.
