RE: PRELIMINARY INJUNCTION ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890), COURT NUMBER 10-00352

1. ON 12/22/2010, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON WOODEN BEDROOM FURNITURE FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-890).

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 10-00352 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.
