ON 06/30/2010, COMMERCE PUBLISHED IN THE FEDERAL REGISTER, 75 FR 37759, THE INITIATION OF ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER OF WELDED CARBON STEEL PIPE AND TUBE FROM TURKEY (A-489-501) FOR THE (05/2010) ANNIVERSARY MONTH. THIS IS A CORRECTION OF PARAGRAPH 2 IN MESSAGE 0204305, DATED 07/23/2010.

2. IN PARAGRAPH 2 OF MESSAGE 0204305, THE DEPARTMENT INADVERTENTLY DID NOT LIST SEVERAL COMPANIES.

3. PARAGRAPH 2 OF MESSAGE 0204305 CURRENTLY READS AS FOLLOWS:

COMMERCE HAS NOT RECEIVED A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY FINDING/ORDER FOR THE PERIODS AND ON THE MERCHANDISE LISTED BELOW, EXCEPT FOR THE FIRMS NOTED. THEREFORE, IN ACCORDANCE WITH SECTION 351.212(C) OF COMMERCE'S REGULATIONS, YOU ARE TO ASSESS ANTIDUMPING DUTIES ON MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION AT THE CASH DEPOSIT OR BONDING RATE IN EFFECT ON THE DATE OF ENTRY.
