1. ON 12/16/2010 THE U.S. COURT OF INTERNATIONAL TRADE (CIT) ISSUED A TEMPORARY RESTRAINING ORDER (TRO) ENJOINING LIQUIDATION OF CERTAIN ENTRIES IMPORTED BY WALGREEN CO. AT THE PORT OF SAVANNAH, GEORGIA, WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN CASED PENCILS FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-827) FOR THE PERIOD 12/01/2007 THROUGH 11/30/2008.
2. THIS TRO WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 10-00373 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED ABOVE. THIS TRO SHALL BE EFFECTIVE FOR ALL ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 3:50 P.M. ON 12/16/2010 AND SHALL REMAIN IN EFFECT UNTIL 12/23/2010.
3. THIS TRO APPLIES TO THE LIQUIDATION INSTRUCTIONS COVERED BY MESSAGE NUMBERS 0214303 AND 0214304, BOTH DATED 08/02/2010.
4. ACCORDINGLY, EFFECTIVE 12/16/2010, UNTIL FURTHER NOTICE, CBP IS INSTRUCTED NOT TO LIQUIDATE ENTRIES OF MERCHANDISE SUBJECT TO THE TRO, AS DESCRIBED IN PARAGRAPH #1 OF THIS INSTRUCTION. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES OF CERTAIN CASED PENCILS FOR THE PERIOD 12/01/2007 THROUGH 11/30/2008 FROM THE PEOPLE'S REPUBLIC OF CHINA UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.
