RE: PRELIMINARY INJUNCTION ON BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM FOR THE PERIOD 05/01/2008 THROUGH 04/30/2009 FOR NSK BEARINGS EUROPE LTD. (A-412-201), COURT CASE NUMBER 06-00334

1. ON 09/01/2010, COMMERCE PUBLISHED THE FINAL RESULTS OF REVIEW OF THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM (75 FR 53661, 09/01/2010). THE REVIEW COVERED MERCHANDISE PRODUCED AND/OR EXPORTED BY VARIOUS PRODUCERS AND EXPORTERS AND THE PERIOD 05/01/2008 THROUGH 04/30/2009. ONE OF THE COMPANIES COVERED BY THE REVIEW WAS NSK BEARINGS EUROPE LTD. (A.K.A. NSK BEARINGS LTD., NSK EUROPE LTD., RHP BEARINGS EUROPE LTD., NSK BEARINGS EUROPE).

2. ON 09/23/2010, NSK CORPORATION, NSK LTD., AND NSK EUROPE LTD. (COLLECTIVELY, NSK) REQUESTED THAT THE UNITED STATES COURT OF INTERNATIONAL TRADE (CIT) ISSUE A PRELIMINARY INJUNCTION TO PREVENT THE LIQUIDATION OF CERTAIN ENTRIES OF BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM PRODUCED BY NSK BEARINGS EUROPE LTD. OR EXPORTED BY NSK EUROPE LTD. THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2008 THROUGH 04/30/2009 (COURT NO. 10-00289).

3. ON 10/15/2010, THE CIT DENIED NSK'S REQUEST FOR AN INJUNCTION IN SLIP OP. 10-118 (COURT NO. 10-00289).

4. ON 10/20/2010, NSK REQUESTED THAT THE CIT ISSUE A PRELIMINARY INJUNCTION TO PREVENT THE LIQUIDATION OF CERTAIN ENTRIES OF SUBJECT MERCHANDISE PRODUCED BY NSK BEARINGS EUROPE LTD. OR EXPORTED BY NSK EUROPE LTD. AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2008 THROUGH 04/30/2009 (COURT NO. 06-00334).

5. COMMERCE DID NOT ISSUE LIQUIDATION INSTRUCTIONS FOR SUBJECT MERCHANDISE PRODUCED BY NSK BEARINGS EUROPE LTD. OR EXPORTED BY NSK

EUROPE LTD. WHILE THE CIT WAS CONSIDERING NSK'S FIRST AND SECOND REQUESTS.

6. ON 10/25/2010, THE CIT ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM (A-412-201) FOR THE PERIOD 05/01/2008 THROUGH 04/30/2009.

7. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 06-00334, CONCERNING A DECISION OF THE INTERNATIONAL TRADE COMMISSION, AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH 8 BELOW.

8. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF BALL BEARINGS OR PARTS THEREOF WHICH WERE PRODUCED BY NSK BEARINGS EUROPE, LTD., OR EXPORTED BY NSK EUROPE LTD., IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) NSK CORPORATION, AND WERE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION DURING THE PERIOD 05/01/2008 THROUGH 04/30/2009. ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

9. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

10. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES DESCRIBED IN PARAGRAPH 8.

11. COMMERCE'S APO DOCKET CENTER WAS SERVED ON 10/27/2010 WITH THE INJUNCTION THE CIT ISSUED ON 10/25/2010. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5:00 P.M. EASTERN DAYLIGHT TIME ON THE FIFTH BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED ON COMMERCE'S APO DOCKET CENTER.
