RE: PRELIMINARY INJUNCTION ON BALL BEARINGS AND PARTS FROM ITALY FOR SKF INDUSTRIE AND SOMECAAT (A-475-201) FOR THE PERIOD 05/01/2008 THROUGH 04/30/2009, CT NO 10-00284

1. ON 09/21/2010, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM ITALY FOR THE PERIOD 05/01/2008 THROUGH 04/30/2009.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE NUMBER 10-00284 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED BELOW.

3. ACCORDINGLY, BASED ON THE PRELIMINARY INJUNCTION AND UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES WHICH MEET THE FOLLOWING CRITERIA:

A. BALL BEARINGS AND PARTS THEREOF FROM ITALY PRODUCED AND/OR EXPORTED BY SKF INDUSTRIE S.P.A. (INCLUDING ITS AFFILIATES RFT S.P.A. AND OMVP S.P.A.), IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) SKF USA INC., SKFUSA INC, SKF USA, INC., SKF USA INC, SKF USAINC, SKFC/O CR INDUSTRIES, SKF C/O CR INDUSTRIES, SKF SEALING SOLUTIONS, SKF SEALING SOLUTIONS AMERICAS, CHICAGO RAWHIDE, CR INDUSTRIES, MRC BEARINGS, OR SKF SPECIALTY PRODUCTS, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2008 THROUGH 04/30/2009.

B. BALL BEARINGS AND PARTS THEREOF FROM ITALY PRODUCED BY SOMECAAT S.P.A., EXPORTED BY SKF (U.K.) LIMITED, IMPORTED BY OR SOLD TO (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION) SKF (U.K.) LIMITED OR SKF (U.K.) LTD., AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/2008 THROUGH 04/30/2009.

4. ANY ENTRIES COVERED BY PARAGRAPH 3 THAT ARE SET FOR LIQUIDATION MUST BE

UNSET IMMEDIATELY. CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

5. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

6. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

7. COMMERCE'S APO DOCKET CENTER WAS SERVED WITH THE ABOVE-REFERENCED INJUNCTION ON 09/21/2010. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 5 O'CLOCK P.M. EASTERN STANDARD TIME ON THE FIFTH BUSINESS DAY AFTER WHICH COPIES OF THIS ORDER ARE PERSONALLY SERVED ON COMMERCE'S APO DOCKET CENTER.
